Summary of findings:	<p>The producer is a copper mine in Chile engaged in mining and copper cathode production. They do not have any suppliers and do not accept materials from outside the mine. They have prepared a Supply Chain Due Diligence Policy in the event that they ever procure any suppliers. This policy is designed to comply with Step 1A of the OECD Due Diligence Guidance For Responsible Supply Chains Of Minerals from Conflict-Affected and High-Risk Areas and align with the Model Policy from Annex II.</p> <p>The Supply Chain Due Diligence Policy includes an explanation of the management structure and control systems that would be in place should suppliers be introduced in the future and the policy be implemented. Information on the producer database and record-keeping system was also provided, including on the ISO 9001 material control systems.</p>

	<p>As the producer does not currently have any suppliers, all materials are obtained from the site itself, located in Chile. The producer refers to the EU CAHRA list to determine CAHRA applicability and has verified that Chile is not a CAHRA.</p> <p>The producer reports publicly on all payments to governments, showing in their annual report the taxes paid to the government of Chile. They also implement a crime prevention model, certified by an independent third party. The producer is not located in an EITI country.</p>
Compliance determination:	<p>A review of all documents, records, and data gathered from management indicates that the Reg Flag Assessment accurately reports a lack of red flags.</p>
